Question No. 83

Senator Brandis asked the following question at the hearing on 12 February 2013:

In relation to prosecutions:

- 1. How many investigations into criminal activity has the Australian Crime Commission launched every year from 2007/08 to 2012/13?
- 2. How many prosecutions have resulted from investigations initiated solely by the Australian Crime Commission from 2007/08 to 2012/13?
- 3. How many disruptions to crime entities were made as a result of ACC intelligence gathering and investigations every year from 2007/08 to 12/13 including what value of illicit drugs, what value of cash taken off the streets and what value of proceeds of crime restrained?
- 4. How many criminal prosecutions came as either a direct or indirect result of *intelligence* reports and briefs, operational analysis and tactical intelligence products drafted by the ACC?
- 5. How many ACC staff have testified for criminal matters before the Supreme Court of any State/Territory every year from 2007/08 to 12/13?

The answer to the honourable senator's question is as follows:

1. The ACC defines investigations as an ACC project.

A large number of ACC projects run across financial years. Table 1.1 provides figures for both new projects initiated within the financial years and the total number of active ACC projects at the end of each financial year. (Note: to provide consistency across the reporting years, projects commenced only to produce strategic intelligence products have been excluded.)

2. As a national agency, the ACC's operating model is to undertake all investigations and operations in partnership with other agencies.

Where the ACC's work pertains to the early stages of an investigation, the ACC is reliant on the advice of partner agencies as to the initiation and progress of resulting prosecution action. In general, partner agencies initiate prosecutions, not the ACC.

Within that context, the number of prosecutions (of which the ACC is aware) that have resulted from ACC projects since 1 July 2007 are listed in Table 2.1 and Table 2.2 below.

3. The statistics in Table 3.1 have been updated from results reported in the ACC's Annual Reports with the most recent data. 'Indirect' statistics indicate results achieved where the ACC can lay some claim to the outcome or assisted in the outcome, but not necessarily being involved throughout the end-to-end process in securing a result. Everything the ACC does is either with or for a partner. As a result, there are instances where the agency has provided assistance to a partner's investigation through use of specialist capabilities, but have not been involved in the whole process. Quantitative indirect results are not ordinarily reported in ACC Annual Reports.

- 4. Records of prosecution held by the ACC include information pertaining to the prosecution itself, and the project to which the prosecution relates. Information regarding the trigger for prosecution is not recorded, therefore this question is unable to be answered.
- 5. This information is not readily accessible, and would require an unreasonable diversion of resources to provide an appropriate answer.
