Operation Mesco - Kevin Rudd YouTube investigation


The Australian Federal Police (AFP) is conducting an investigation into the possible theft of Commonwealth property in connection with the disappearance of an HDV tape containing footage of the former Prime Minister Kevin Rudd. On 17 February 2012, clips from this tape were uploaded onto YouTube.

The AFP approached AGD about the possibility of making a mutual assistance request to the United States for subscriber and IP information in relation to the YouTube user account. Following discussions with the US, AGD advised the AFP that there was insufficient information to support a request for these records at this time.

 As a matter of long standing practice the Department does not comment on operational law enforcement matters.

BACKGROUND

Factual background of alleged offence

During his time as Prime Minister, Kevin Rudd made a recording on a mini-HDV tape (the videotape) of himself delivering an address to citizens of the People's Republic of China on the 60th Anniversary of the Chinese Communist Party. The videotape was owned by the Department of the Prime Minister and Cabinet (PM&C). The videotape was labelled and stored in the Office of the Prime Minister in Parliament House in Canberra.

On 17 February 2012 an unknown person using the identifying handle 'HappyVegemiteKR' uploaded a parody video titled 'Kevin Rudd is a Happy Little Vegemite' to YouTube. This YouTube clip contained footage from the videotape.

AFP investigation into the alleged theft of Commonwealth Property

On 15 March 2012 Mr Rudd referred the alleged theft of Commonwealth property (namely, the videotape) to the AFP.

AGD involvement - enquiries with the US Department of Justice

On 11 May 2012 the AFP contacted AGD about the possibility of making a mutual assistance request to the US for subscriber and IP information in relation to the 'HappyVegemiteKR' YouTube user account.

After extensive liaison with the AFP about the progress of the investigation and the relevance of the material to the alleged offence, AGD made enquiries of the US Department of Justice (the Central Authority for US mutual assistance requests) as to whether there was sufficient information currently available to satisfy the US threshold for obtaining the authorisation necessary to compel YouTube to provide this information. On 3 October 2012 the US Department of Justice confirmed that, on the basis of the information currently available, the US was not likely to be in a position to satisfy the necessary thresholds for obtaining the authorisation.

Following this advice, AGD

informed the AFP that we would not be in a position to make a mutual assistance request to the US at this time, but could reconsider this position if there were developments in the investigation.

AGD understands that the AFP investigation is ongoing.

There has been ongoing media interest in this matter; including most recently a media enquiry from Sydney Morning Herald journalist Lenore Taylor on 11 October 2012.
