Senator Carr (Written) asked:

The Department's June 2013 Submission to the Senate Legal and Constitutional Affairs Legislation Committee Inquiry into the Migration Amendment (Temporary Sponsored Visas) Bill 2013 included a chart at p12 titled 'Graph 1: ANZ Job Advertisement Series and Subclass 457 Primary Applications lodged to 31 May 2013', shown here:

Graph 1: ANZ Job Advertisement Series and Subclass 457 Primary Applications lodged to 31 May 2013.

Provide an update of this chart, and the data underlying the chart, showing the relationship between 457 primary visa applications lodged and the ANZ Job advertisement series, to end-January 2014.

Is the Department closely monitoring the relationship between these two data series?

Has the large gap, evident since around January 2011, been closed or are 457 visa lodgements still running ahead of the ANZ Job advertisement series?


With regard to 457 visa applications lodged in 2012-13 and 2013-14 to end-January 2014, how many clients were located onshore and how many were offshore at the time visa applications were lodged in each of these periods?

Provide the same data (i.e. onshore/offshore split) for 457 visa grants, for 2012-13 and 2013-14 to end-January 2014.

Is the onshore proportion of total 457 visa applications lodged increasing or decreasing, and likewise for 457 visa grants?

Answer:

The requested chart displaying ANZ job advertisement data and subclass 457 primary applications lodged to 31 January 2014, is shown below.



As displayed in the above chart, subclass 457 primary applications lodged fell sharply between July 2013 and 31 January 2014. The large spike in May/June 2013 was most likely activity timed to precede reforms and increased VACs implemented on 1 July 2013.

As at 31 January 2014, subclass 457 primary application lodgements appear to have returned to be broadly in-line with the ANZ Ads Index as it was prior to mid-2011. The department will continue to monitor these two data series; the next set of data will not be available until July 2014.

In relation to the other specific questions asked, the department provides the following responses:

- In 2012-2013 there were 42 610 subclass 457 primary visa applications lodged onshore and 38 937 lodged offshore. In 2013-2014 to end of January 2014 there were 13 125 primary subclass 457 visa applications lodged onshore and 13 864 lodged offshore.
- In 2012-2013 there were 33 441 subclass 457 primary visas granted onshore and 35 040 granted offshore. In 2013-2014 to end of January 2014 there were 16 098 subclass 457 primary visas granted onshore and 15 427 granted offshore.
- Onshore application lodgements as at 31 January 2014 were 38 per cent lower than they were at 31 January 2013.

• There were 16 098 onshore visa grants between 1 July 2013 and 31 January 2014, compared to 19 870 onshore visa grants between 1 July 2012 and 31 January 2013, a year-on-year drop of 19 per cent.

Note 1: Subclass 457 lodgement figures for 2013-14 are subject to variation.

Note 2: From May 2012, the ANZ changed the methodology for the ANZ Job Advertisement Series. This means that all previously published figures have been revised. The ANZ has published a graph comparing the original and revised series since July 1999. The revised figures are consistently lower.

However, the ANZ has only published the revised figures from April 2010. The variation in the period April 2010 to March 2011 to determine a factor that can be used to adjust the earlier data. The estimated figures are shown in italics.

Note that because of the new methodology, more recent figures in the job series are subject to revision by ANZ.
