(c) Was that a one-off funding initiative to provide MRCs with computer hardware and software? (d) Was it then expected that they would fund replacements out of their own budgets after that?

Answer:

- (a) Yes.
- (b) In July 1999, an electronic software system called the Settlement Client Information System (SCIS) was issued to Migrant Resource Centres (MRCs)/Migrant Service Agencies (MSAs) to replace their previous method of client data and statistical reporting.
- (c) The development and implementation of SCIS was fully funded by the Department and was supported with an ongoing freecall helpdesk service. Prior to implementation, the Department funded MRCs/MSAs for the purchase of computer hardware. The software has been regularly updated to improve its performance. The last release was in mid 2002.

In the 2002-03 program year, additional funds were available under the 'Grants for Migrant Community Services' Administered Item appropriation, on a one-off basis. As a result, two MRCs were provided with additional funds to purchase computer equipment.

(d) Yes. It is not the Department's practice to provide open-ended funding to external organisations for their computer equipment.

Note: This figure represents the change in economic forecast parameters since the last published estimate and as such will differ from that published on in table 2.1.2.1 of the PBS, which represents the cumulative change between financial years as a result of the application of economic parameters.

The increase in the Humanitarian Program from 12,000 to 13,000 places resulted in additional funding being allocated for the provision of English tuition. The funding will contribute to both the Special Preparatory Program (SPP) and the AMEP.

Increased funding for Settlement Services will enable humanitarian entrants with low levels of schooling in the 16-24 year old age group to be offered up to 400 hours of tuition under the SPP, and supplement existing hours offered to those over 24 years up to 100 hours. Funding allocated in 2004-05 includes \$8.244m for English tuition, \$0.05m for systems development, and \$2.35m for development of curriculum materials. Funding in future years is solely for English tuition, with the exception of 2007-08 which also includes \$0.150m to enable a review of the additional hours.

Funding has been allocated through the Migration (non-humanitarian) program to assist eligible spouses and dependents of the new Skilled Independent Regional visa, and the adult members of families recruited under MedicarePlus, to access the AMEP.
