Senator Nettle asked:

- 1. According to QoN 44, Ms Rau's case appeared on the Detention Review Committee (both central office and Qld office) on a number of occasions. What was discussed and what was decided? Can the committee be provided with the minutes from the relevant meetings?
- 2. According to QoN 44, Ms Rau was visited and interviewed by the Honorary German Consul in Brisbane. Did the consul provide DIMIA with a report of this interview in regard to Ms Rau's status? If so, please provide a copy of this report to the committee?
- 3. The initial medical assessment of Ms Rau was conducted by International Health and Medical Services (subcontracted from GSL) on the 6 October 2004. What was the result of this assessment? Was there any indication of a mental illness or need for follow-up?
- 4. According to QoN 44. The German Foreign Minister indicated to the Australian Embassy that from the letter they received from Ms Rau, they could tell she was not fluent in German or had no schooling. Did DIMIA review Ms Rau's status as a suspected 'unlawful non-citizen' given this contradiction to her story? If not, why not?
- 5. It seems by as early January it was clear, even to DIMIA and GSL, that Ms Rau was suffering some kind of mental illness and the question was more whether it was serious enough for Ms Rau to be sectioned under the Mental Health Act, or continue to have her behaviour "modified" at Baxter through the behaviour modification plan including the management unit and red one compound. Given this, why was reasonable suspicion that she was an unlawful non-citizen not reviewed and overturned?
- 6. What was discussed with the Minister's office on 19 January in relation with Ms Rau? Was there any action resulting from this discussion?
- 7. Given the level of concern at least 32 pieces of correspondence the Minister's office received, what did the office do to follow the Rau case up?

Answer.

- 1. Excerpts from the agendas and minutes for the Detention Review Committee meetings and Queensland detention review meetings where Anna Brotmeyer/Schmidt was mentioned are attached.
- 2. A short one page report of this interview was provided to the Department. The Department has written to the Honorary German Consul to request their permission for the release of this information to the Committee.
- 3. Departmental records indicate that Ms Rau (Anna Brotmeyer aka Schmidt) was referred to Professional Support Services on 6 October 2004. The referral reasons state

"Reports from QLD correction
Odd behaviour on induction refused to answer all questions mood labile
Crying placed onOBS"

There was no specific indication of mental illness and cites the assessment conclusion of the Princess Alexander Hospital (...mental health fits no mental health criteria.)

4. Ms Rau's (Anna Brotmeyer aka Schmidt) case remained under review during the period of her detention.

The information received from the German Ministry of Foreign Affairs on 3 December 2004 was one of many avenues that were being pursued in attempts to identify Ms Rau (Anna Brotmeyer aka Schmidt). The fact that the letter suggested to the Ministry that Ms Rau (Anna Brotmeyer aka Schmidt) "...was not fluent in German (or maybe not literate if she has had no schooling), as the grammar was not correct." did not in itself, alleviate the reasonable suspicion surrounding Ms Rau's (Anna Brotmeyer aka Schmidt) citizenship status.

- 5. Mental illness alone was not necessarily determinative of her immigration status.
- 6. Ms Rau's case was discussed along with a number of detention cases and detention related matters. The focus of discussion on Ms Rau (Anna Brotmeyer aka Schmidt) was to provide the Minister's office with information on the status and progress of her case. No specific additional action or changes in the Department's course of action at the time resulted from this discussion.
- 7. A meeting was scheduled with the Minister's Office on the 19th January 2005 to discuss Ms Rau (Anna Brotmeyer aka Schmidt) and others. In addition, briefing in the form of a current issues brief was sent to the Minister's Office on the 31st January 2005.






