Senator Ludwig asked the following question at the hearing on 24 May 2007:

- a) How many civil celebrants are currently registered in Australia?

- b) How many religious celebrants are currently registered in Australia?
 - (i) Provide a breakdown per state;
 - (ii) Provide a breakdown into gender.
- c) How many other celebrants are currently registered in Australia?
 - (i) Provide a breakdown per state;
 - (ii) Provide a breakdown into gender.
- d) What is the total number of all those authorised to perform legal marriages in Australia?
- e) How many individual Celebrants are appointed as both Civil Marriage Celebrants and Non-aligned Religious Celebrants?
 - (i) Why are they appointed as both?
- f) How many civil celebrants are currently on the waiting list to be registered?
- g) How many registration applications has the Attorney-General's Department finalised per month, since the beginning of the 2006-07 financial year?
- h) How many registration applications has the Attorney-General's Department received per month, since the beginning of the 2006-07 financial year?

The answer to the honourable senator's questions is as follows:

a) The Commonwealth Marriage Celebrants Program draws no distinction between 'civil marriage celebrants' and those conducting religious marriage ceremonies. All applicants must satisfy the same statutory criteria (see questions 12 and 19 for more details about these requirements). The number listed on the Register of Marriage Celebrants as available to perform civil ceremonies is 3,270.

- (ii) Breakdown by gender: 2,336 Females; 934 Males.
- b) Marriage celebrants performing religious marriage ceremonies may be registered by either the Commonwealth or the States and Territories, depending on whether or not they belong to a recognised denomination under section 26 of the *Marriage Act 1961*. The number of marriage celebrants performing religious ceremonies registered by the Commonwealth is 1,451.

- (ii) It is not possible to provide a breakdown by gender because officers of States and Territories are authorised according to the position they hold not as individuals.
- d) The total number of all those authorised to perform legal marriages in Australia is 27,168.
- e) The total number of individual active marriage celebrants registered to perform both civil marriage ceremonies and non-aligned religious marriage ceremonies is 30.
 - (i) As noted above in the answer to (a), all marriage celebrants registered by the Commonwealth under the Marriage Celebrants Program must comply with the same statutory provisions. There is no distinction in the application process. The Register of Marriage Celebrants lists whether a marriage celebrant is available to conduct religious or non-religious (civil) marriage ceremonies. The *Marriage Act 1961* contains separate provisions for religions and non-religious marriage ceremonies. The number listed on the Register of Marriage Celebrants as available to perform both religious and non-religious marriage ceremonies is 30. These people have been able to satisfy the Department that they understand the legal provisions related to religious and non-religious marriage ceremonies.
- f) As of 5 June 2007, there were 1,235 marriage celebrants currently on the waiting list to be registered.
- g) The Department finalised a total of 874 registration applications from 1 July 2006 to 31 May 2007. This number includes those applications on which no further action was taken because they were incomplete, those applicants assessed as suitable and put on the waiting list, those not approved and those registered.
