Review preparatory meetings have commenced. Some countries are strong supporters of the process while others are strongly opposed. Caroline Millar feels that there are some countries who are now supportive. She would like to promote Australian Indigenous rights internationally. The Australian government has not yet indicated whether it will attend in 2009. The Commission should not pull back on participation just because there is a risk that Islam will become a major issue.

3.2 Durban Review Conference, April 2009

Marg Donaldson attended to discuss the paper on the Commission's participation in the Durban Review Conference.

President Branson reported her discussions with Caroline Millar about the Conference. According to CM, the Australian Government is cautious about whether to attend, but so far no official has attempted to urge them to attend. CM said that New Zealand will be attending, but is remaining fairly quiet, intervening only on 'soft' issues. The UK's position is determined by the EU's position. The position of the US is unknown. CM recommended that Australia attend the conference and take soft approach, making only strategic interventions.

Commissioner Calma noted that it is important to have good representation of Indigenous peoples at the Conference. Depending on other engagements at the time, he will most likely take a member of RDU to attend with him.

Part of RDU's role in coordinating the Commission's participation will include liaising with DFAT, in particular in relation to the questionnaire on the Durban Review that has been received. RDU can also engage with NGOs in preparation for the conference.

Decision: The Commission approved the recommendation that the Commission attend the Durban Review Conference. The Commission will engage with DFAT and NGOs in preparation for the Conference. RDU will report on the status of preparations for the Conference at the Commission meeting in February. Action item 2]
