Senator Birmingham asked the following question at the hearing on 25 May 2010:

Buildings' efficiency:

Please list every building occupied by the Department, noting for each whether an energy efficiency audit has been undertaken.

Where an audit has been undertaken, please indicate:

- a. What rating was achieved and
- b. What action has been taken to improve energy efficiency as a result of any audit undertaken?

The answer to the honourable senator's question is as follows:

Note for all buildings: The Department recently completed an Environmental Management System (EMS) which is a plan to manage building environmental performance including energy efficiency and water usage and other waste management issues for all buildings it occupies. An important contribution to the development and ongoing success of the system is input received from the Department's 'Green Group'.

The Department also investigates and undertakes energy savings programs on an ongoing basis such as the management of afterhours lighting and sensor activation of lighting. These initiatives continue to be introduced across the property portfolio, regardless of the size and audit & reporting requirements applicable to each building.

The ratings indicated below accord with the NABERS (National Australian Built Environment Rating System) scale with the highest achievable rating of 6. This is not always practicable for Government Departments and Agencies in view of the generally higher level security and communication requirements of the Protective Security Manual.
