**BUDGET ESTIMATES HEARING: 23 - 24 MAY 2011** 

IMMIGRATION AND CITIZENSHIP PORTFOLIO

(BE11/0082) Program 1.1: Visa and Migration

Senator Abetz (L&CA 43) asked:

In relation to the Enterprise Migration Agreements, provide a list of the 13 eligible projects and the 21 at the feasibility or approval stages and in which states they are located.

## Answer.

According to Australian Bureau of Agricultural and Resource Economics and Sciences (ABARES) data, there are now currently 14 major projects, detailed in Table 1 below, which prima facie meet the eligibility criteria of \$2b capital expenditure and a peak workforce of 1500, for an Enterprise Migration Agreement. This number has been updated since the Budget Estimates Hearing to reflect current ABARES data as at 26 May 2011.
