Senator Cash (L&CA 40) asked:

With relation to AE12/0394, what is the breakdown by cost per provider?

Answer.

As advised in the department's response to AE 12/0394, in 2010-11 there were twenty-three contracted service providers under the IAAAS. They were paid a total of \$22.860 million. They are listed along with a breakdown of the expenditure at Attachment A.

Attachment A also gives a breakdown of the expenditure by service provider for the month of July 2011.

The twenty-three contracts expired on 31 July 2011 after a five year term (three years plus a two year extension) following a public tender in early 2006.

New contracts with twenty-two successful tenderers took effect from 1 August 2011 following a public tender in early 2011. The contracts are for a period of three years with provision for up to two, two year extensions at the Department's discretion. The twenty-two new providers are listed along with a breakdown of the amount invoiced from 1 August 2011 to 30 April 2012 at Attachment B.
