On 1 July 2011, a revised business model and new contract regions came into effect. While there is no direct correlation between the old contract regions (prior to 1 July 2011) and the new regions (post 1 July 2011), for the purpose of this question, the client numbers provided for 2010/11 had been mapped into the new contract regions (based on clients' residential postcodes instead of service provider contract regions).

Prior to 2011/12, distance learning was delivered by service providers in each individual region. Since July 2011, distance learning has been delivered nationally by one service provider. To allow comparison with 2011/12 and 2012/13 data, all distance learning clients from 2010/11 have been grouped as 'Distance Learning'.
