- g) how many staff were engaged in processing imports declarations

- c) 23,795 sea import declarations were processed through COMPILE.
- d) The following table contains the processing numbers for ICS EDI messages and elapsed time between the receiving of the sea import declaration message into Customs to the time the associated response message (informing the client of the outcome of the transaction) leaves Customs.
