Under section 298(2) *Proceeds of Crime Act 2002* (the Act), the Minister for Justice and Customs can approve funding for programs for: crime prevention measures; law enforcement measures; drug treatment measures; or diversionary measures that relate to the use of illegal drugs. Australian Government agencies can apply directly to the Minister for Justice and Customs for funding for crime prevention and law enforcement programs. The Attorney-General's Department provides advice to the Minister on proposals after consultation with relevant law enforcement agencies.

The seven drug prevention and treatment programs were assessed, prior to their approval, by the Department of Health and Ageing under the National Illicit Drug Strategy as part of the Non-Government Organisation Treatment Grants Program. The three drug treatment programs announced by the Prime Minister on 10 October 2005 were put forward to the Government by the Australian National Council on Drugs (ANCD).

New arrangements for allocating funding to non-government organisations under the Act were recently announced. The new arrangements involve a two stage process for non-government organisations seeking funding to address a specified area of crime prevention, drug treatment or drug diversion: an initial Expression of Interest, followed by detailed applications from preferred applicants. The initial EIO process is expected to lessen the administrative demands placed on often under-resourced non-government organisations. Drug treatment and diversion will receive priority.

Expert panels will assist in the selection process to increase transparency, community participation and expertise. The expert panel for drug treatment and diversion proposals will include the Australian National Council on Drugs, the National Drug and Alcohol Research Centre, and the Department of Health and Ageing. The expert panel for crime prevention proposals is yet to be finalised.

Programs for non-government organisations are limited to a maximum of \$750,000 per approved program with a cap of \$250,000 that can be paid out to each program in any one year. Programs must also run for a minimum duration of three years (in line with current drug treatment project proposals).

The Department is currently developing new Guidelines, Expression of Interest and detailed application forms which will also be available on the web.
