Senator Barnett asked the following question at the hearing on 19 October 2009:

Provide details on consultation, including dates, times and with whom, the Court has had with the Law Society and legal fraternity concerning the possibility of the absence of a full time registrar positioned in Hobart.

The answer to the honourable senator's question is as follows:

The Court undertook an extensive consultation program regarding the Small Registries Review. External Court users and others who were likely to have an interest in or were potentially affected by the Review were provided a copy of the Small Registries Review Consultation Paper in the week commencing 27 April 2009. This included the Law Society and the Independent Bar.

The feedback received from various external Court users, including Luke Rheinberger, President of the Law Society of Tasmania, Duncan Kerr MP and John Corcoran, President of the Law Council, was thoroughly considered prior to the decision on the Small Registries Review being made by the Registrar/CEO. In essence, the consultation process was undertaken over a period of two months.
