7. There is no visa category referred to as "protective permanent residency". However, in the context of questions regarding Partner visas, the question has been interpreted as enquiring about the number of Partner visa applicants who have been granted visas on the basis of having been determined to be victims of family violence.

Australia's Migration Program enables people (generally those who are in Australia on a Provisional Partner visa) to apply and remain in Australia if a partner relationship breaks down because of family violence. The family violence provisions were introduced in response to community concerns that some partners might feel compelled to remain in abusive relationships rather than end the relationship and be required to leave Australia.

Claims of family violence are initially considered by departmental officers. Where the case officer determines that the claim is doubtful, the case is referred to an independent expert for an opinion. The independent expert is currently a professional Social Worker within Centrelink who has specialist experience in family violence matters. The opinion of the independent expert is binding on the decision maker.

The following table sets out the number of family violence claims over the last three program years, the number of referrals to Centrelink and the outcome of referrals.
