

Occasionally there may be unavoidable delays in processing payments, for example in verifying the satisfactory completion of work. For 2009-10, 92% of payments were made within 30 days. For the remaining 8% more than half were paid within 1 to 14 days after the due date. For 2010-11 to 18 October 2010, 99.2% of payments were made within 30 days. For the remaining 0.8%, more than half were made within 1 to 14 days after the due date.

Administrative Appeals Tribunal The Administrative Appeals Tribunal has paid its accounts to all suppliers in accordance with Government policy in terms of time for payment, with the exception of a small number of accounts. A small number of accounts were not paid in accordance with Government policy because they were the subject of dispute with the supplier, required some correction or required additional documentation before they were considered sufficiently compliant with agency guidelines to be paid. 

a)	The Australian Federal Police (AFP) has paid its accounts to all suppliers in accordance with Government policy in terms of time for payment, with the exception of a small number of accounts. The AFP's accounts payable and financial processes are currently a manual process. Legislative, audit and budgetary requirements for correctly authorised, coded and goods receipted invoices necessitates the need for some invoices to be returned to responsible business areas to obtain missing information or the required delegate's authorisation. In addition, validation of services having been fully delivered needs to be confirmed prior to payment being made. Invoices are sent to numerous billing addresses within the AFP and invoices can be delivered to incorrect business areas causing delays. The automation of accounts processes and centralised billing arrangements are expected to lead to improvement in the timeliness of payment. For the financial year 2009-10 95% of payments were paid within 30 days, for the remaining 5 percent more than half were paid within 1 to 14 days after the due date. For the financial year 2010-11 up to 18 October 2010 95% of payments were paid within 30 days, for the remaining 5 percent more than half were paid within 1 to 14 days after the due date. The AFP is largely meeting the thirty-day payment time. In addition, the AFP continually monitors its payments performance and is required to report annually to the Department of Innovation, Industry, Science and Research on timeliness of payments to small business.
