Senator Cash asked:

What are the KPIs for the processing by visas? Please provide an analysis of whether targets have been met according to visa category for the last 2 financial years.

Answer.

The table below provides processing time service standards for the various visa caseloads for the last two financial years, showing the percentage of applications processed within the service standard time.

The Department aims to process 75 per cent of cases within the service standards. However, actual processing times may vary from these standards as the following notes explain:

- The service standards are indicative only. Individual cases may be decided in longer or shorter periods than the service standard, depending on a range of factors, individual circumstances, program integrity and the complexity of each case.
- The service standards apply to visa applications lodged with complete documentation. Applications can take longer than the processing time service standard if lodged without all the required documentation.
- The service standards do not include the time taken to process nominations and/or sponsorship applications.
- Processing times can vary by location, reflecting the differing circumstances of national and regional caseloads.
- For applications submitted for a visa online through the Department's website, the processing times may be different from those shown below. Information is provided in the "general information" in the e-visa online services.

In the following table:

- 'Onshore' means the applicant is in Australia at the time the application is lodged.
- Low risk applies to nationals from countries which issue Electronic Travel Authority (ETA) or eVisitor eligible passports. High risk countries are those which are not ETA or eVisitor eligible.
- 'Group' refers to processing priority groups. Group 1 is the highest priority.
