Senator Cash asked:

457 visas and skilled migration: How many 457 visas were granted in 2010-2011? How many so far this year to date? In what industries? How many are subject to a Labour Agreement?

Answer.

In 2010-11 48 080 Subclass 457 visas were granted - 46 690 Subclass 457 visas granted in association with the Standard Business Sponsorship stream of the program and 1390 granted in association with a Labour Agreement.

In 2011-12 to 31 October 2011, 22 830 Subclass 457 visas have been granted – 22 130 have been granted in association with the Standard Business Sponsorship stream of the program and 700 in association with a Labour Agreement.
