## **Question No. 134**

## Senator Ludwig asked the following question at the hearing on 18 November 2013:

- a) What is the agency's hospitality spend for this all events including any catering and drinks costs.
- b) For each Minister and Parliamentary Secretary office, please detail total hospitality spend from 7 September 2013 to date. Detail date, location, purpose and cost of all events including any catering and drinks costs.
- c) What is the agency's entertainment spend from 7 September 2013 to date? Detail date, location, purpose and cost of all events including any catering and drinks costs.
- d) For each Minister and Parliamentary Secretary office, please detail total entertainment spend from 7 September 2013 to date. Detail date, location, purpose and cost of all events including any catering and drinks costs.
- e) What hospitality spend is the agency planning on spending? Detail date, location, purpose and cost of all events including any catering and drinks costs.
- f) For each Minister and Parliamentary Secretary office, what hospitality spend is currently being planned for? Detail date, location, purpose and cost of all events including any catering and drinks costs.
- g) What entertainment spend is the agency planning on spending? Detail date, location, purpose and cost of all events including any catering and drinks costs.
- h) For each Minister and Parliamentary Secretary office, what entertainment spend is currently being planned for? Detail date, location, purpose and cost of all events including any catering and drinks costs.
- i) Is the agency planning on reducing any of its spending on these items? If so, how will reductions be achieved and what are the estimated savings over each year of the forward estimates?

## The answer to the honourable senator's question is as follows:

a) The AFP performs formal reviews of Hospitality and Entertainment expenses throughout the year. The timing of this Senate Estimate request sits outside the AFP's normal review timetable. As a result, the AFP has been unable to compile credit card data for the requested period. The total of Hospitality and Entertainment expenses identified by the

AFP is \$34,694. This does not include costs of graduation ceremonies from the AFP College as these costs cannot be feasibly isolated from course costs. Details of known Hospitality and Entertainment expenses are set out below.
