Senator Singh asked the following question at the hearing on 18 November 2013:

- 1. What was the Full Time Equivalent (FTE) staff establishment for the Department that is, what was the establishment as at the 2013/14 budget?
- 2. What are the FTE numbers by division?
- 3. What are the actual staffing levels in each division?
- 4. How many staff are employed on fixed term contracts in the Department?
- 5. How many staff are employed on a non-ongoing basis?
- 6. Have there been any appointments to the Department since the election?
- a. If so, who was appointed, to what position where they appointed, what was the process followed and are they permanent or fixed term appointments?
- 7. The Government has announced that it plans to cut the Public service by 12,000. Is that target based on actual staff numbers or is it based on a savings target?
- 8. Can you confirm that this 12,000 cut in staff levels is additional to the redundancies announced in the 2013/14 budget?
- 9. What is the separation rate for your Department for the last 4 financial years?
