# a) Departmental officers accompanying Minister and/or Parliamentary Secretary

For the financial year to date, to 30 September 2013, four departmental officers accompanied the Minister on trips. The total cost for these four trips was \$18,828.

Factors contributing to travel expenditure in the department for the financial year to date include travel of departmental officers:

- to/from/between the department's approximately 80 offices in Australia and offshore
- to/from/between detention centres within Australia, including on Christmas Island
- to/from regional processing centres (RPCs) on Manus Island in Papua New Guinea (PNG) and Nauru
- to state offices and overseas posts to monitor operations and conduct interviews
- to accompany people who are being involuntarily removed from Australia
- to attend meetings and conferences as part of Australia's international engagement with other immigration jurisdictions, including Indonesia, Malaysia, the United Kingdom and the United States of America
- between venues to attend meetings, training, conferences and workshops.

# c) What travel is planned for the rest of the year, from 7 September 2013? Also provide a reason and brief explanation for the travel.

Travel for the rest of the year is yet to be determined. Operational requirements that will impact travel costs are as specified at b) above.

# d) What is the policy for business class airfare tickets?

The department's travel policy provides that all domestic air travel (including the domestic leg of any international flight) must be in economy class unless there is an entitlement to travel business class or an approved written business case to fly business class. Approval should be on an exceptions basis. All international air travel must be in economy class or business class.

# e) Lounge memberships

The department's travel policy states that if an employee is required to fly regularly (eight or more times a year) and there is a business need, a delegate may approve an airline lounge membership for that employee.

The department has record of 428 employees holding a Corporate Lounge Membership as at 1 December 2013 as follows:

The whole of Australian government's lounge membership rates paid by the department are:

- Annual Virgin Lounge Membership: \$249.00 plus one off joining fee of \$199.00.
- Annual Qantas Lounge Membership: \$290.00 plus one off joining fee of \$220.00.

# f) Administrative staff travel

The department spent \$845 in the financial year to date, to 30 September 2013, on travel for one staff member to accompany an SES officer. Their duties included facilitating stakeholder discussions and familiarisation with the staff and work location.
