Answer:

(a) The department's official hospitality reporting process is completed on a quarterly basis. The department's official hospitality expenditure from 7 September 2013 to the end of the first quarter of the 2013–14 financial year ending 30 September 2013 was:

(b) The Department of Immigration and Border Protection (DIBP) has expended \$236.50 for official hospitality on behalf of the Hon Scott Morrison MP, Minister for Immigration and Border Protection. Details are listed below.

\$236.50 was for a dinner hosted by Minister Morrison for Mr David Adeang, Nauru Minister for Justice and Major General (Rtd) Jim Molan AO DSC. The dinner was held to undertake high level discussions and build relationships. The dinner was held on 25 September 2013 at Ottoman Cuisine, Barton, ACT.

To date, there has been no funds expended for official hospitality on behalf of Senator the Hon Michaelia Cash MP, Assistant Minister for Immigration and Border Protection.

- (c) The department does not differentiate between hospitality and entertainment. The department's finance system captures information on expenditure for both entertainment and hospitality in a combined format referred to as official hospitality. Please refer to answer (a).
- (d) Since 7 September 2013, the Department of Immigration and Border Protection has not expended any funds for the entertainment on behalf of the Minister for Immigration and Border Protection or the Assistant Minister for Immigration and Border Protection.
- (e) The department expects that expenditure on official hospitality for 2013–14 will be consistent with 2012–13 expenditure and will be approximately \$100 000. Detailed information on planned official hospitality expenditure is not available.
- (f) There is currently no hospitality spend currently being planned for either the Minister for Immigration and Border Protection or the Assistant Minister for Immigration and Border Protection.
- (g) The department does not differentiate between hospitality and entertainment. Please refer to answer (e).
- (h) There is currently no entertainment spend being planned for on behalf of the Minister and Immigration and Border Protection or the Assistant Minister for Immigration and Border Protection.
- (i) The current level of expenditure on hospitality and entertainment is considered appropriate for a department that has international engagement with many stakeholder groups. However, the department will continue to focus on cost effective outcomes.
