The reduction in FTEs is due to numerous factors including natural attrition and movement within the Australian Public Service. As at 28 February 2011 the department had 81 positions advertised in the Commonwealth Gazette.

1. Sixty four graduates commenced with the Department of Agriculture, Fisheries and Forestry graduate development program on 17 January 2011. The Australian Bureau of Agricultural and Resources Economics and Sciences' graduate program continued throughout 2010 and its graduates are included in the 76 graduates in the Hansard transcript for 21 February 2011(page 19).

On 24 May 2010, the department advised, (Hansard transcript page 11), that it would resume the graduate development program at previous levels of approximately 60 graduates in 2011.

For costs see question 2 below.

2. Costs associated with Department of Agriculture, Fisheries and Forestry graduate development program (including training and development, recruitment and relocation costs) are paid over two financial years.

The Department of Agriculture, Fisheries and Forestry graduate development program numbers were:

- 4. Vacancy control is not being used in the department to assist with meeting savings measures.
- 5. As the department monitors the time taken to fill vacancies, the department is able to compare the current average time to fill a vacancy with the previous 5 years. The current average time taken to fill a vacancy is 61 calendar days. The average time taken to fill a vacancy over the past 5 years was:
 - 2010 70 days
 - 2009 62 days
 - 2008 82 days
 - 2007 82 days
 - 2006 80 days

- 2. For the period between 1 December 2007 and 28 February 2011 Minister Burke spent \$5 476 and Minister Ludwig spent \$232 on shredding/secure removal of documents in the Minister's/Parliamentary Secretary's offices. This is a total of \$5 708.

All figures are GST exclusive and reflect the total costs of shredding/secure removal of documents. These figures reflect the cost of shredding/secure removal of both confidential and unclassified documents as people often shred and place in secure removal containers unclassified documents.
