## GILLARD GOVERNMENT WELCOMES FORESTRY AGREEMENT

The Australian Government today welcomed the landmark agreement between industry and environmental NGOs in Tasmania on the future of the Tasmanian forestry industry and the future of the state's native forests.

Minister for Sustainability, Environment, Water, Population and Communities, Tony Burke, said, "It is a credit to those involved that after decades of disagreement they have been able to work through complex problems to forge a new consensus." .

Minister for Agriculture, Fisheries and Forestry, Senator Joe Ludwig, said the Gillard Labor Government recognises the need for a balanced and sustainable approach to native forest management.

"I know many people have worked very hard to get this agreement to this stage," Minister Ludwig said.

"Today's agreement is a positive move, balancing the conservation and sustainable development and management of Tasmania's forest resources."

The Minister for Regional Australia Simon Crean said the agreement was a step in the right direction.



"With this agreement in place we will work with Tasmanian timber communities as they
