Over the last two years, the Department of Transport and Regional Services (DOATRS) has had face-to-face discussions with officials of European Governments on access arrangements as follows: Poland (March 2003), Austria (October 2003), the United Kingdom (May 2004) and Belgium (October 2003). There has also been contact with The Netherlands (June-September 2004) and Malta (March-December 2003).

In addition, there have been three face-to-face meetings with officials of the European Commission (in October 2003, August and December 2004) about access arrangements.

There are related ongoing instances of e-mail, written correspondence, fax or telephone contact with these Governments and the European Commission.

As the DOTARS has prime carriage of Australia's aviation arrangements with other countries, other Agencies would not usually have made contact on access arrangements other than through us.
