Senator Colbeck asked:

Senator COLBECK—What is the current staffing of the agency and what has it varied since we last discussed that in November?

Mr Schaeffer—In the portfolio additional estimates statements on page 28, our revised target on the current staffing levels was 4,481.

Senator COLBECK—That is a target; I want to know what they are now though. **Ms Hazell**—The department currently employs 4,255 full-time staff, 914 part-time staff and 141 casual staff. That gives you a total of 5,310 based on a headcount of staff.

Senator COLBECK—So how do I convert that so I can compare apples with apples? **Ms Hazell**—With great difficulty. We could take on notice an ASL calculation for you but the FTE figure, I am advised, is broadly on track to meet that ASL target at year end.

Senator COLBECK—But there is no way known that I can check that because I do not have a conversion factor.

Dr O'Connell—We can undertake to give you our conversion from the headcount to the ASL number that was in the additional estimates.

Answer:

Full-time Equivalent (FTE) at 31 January 2009 was 4,721. FTE is used as a measure of standard full time workloads and is calculated by dividing an employee's hours by the normal full time hours for the employee's classification and it is a 'point in time' value such as 31 January 2009. The FTE figure includes ongoing employees, including staff on temporary transfer from other government agencies being paid by the department, non-ongoing employees, casual employees, and employees on leave without pay where they will return within three months.

The Average Staffing Level (ASL) at 31 January 2009 was 4,465 compared with an estimated ASL for 2008-09 of 4481 as disclosed in the Portfolio Additional Estimates Statements 2008-09 (page 28). This is defined as the year to date average of FTE and is most commonly used for forecasting purposes. ASL allows for comparison between employment in particular period, usually financial years, rather than reflecting the actual number of staff being employed on a specific date.

Headcount: The headcount as at 31 January 2009 was 5,310. Headcount is all ongoing, non-ongoing and casual staff employed in the department at a 'point in time' such as 31 January 2009, where each employee is given the same numeric value of

one (1), regardless of whether they are full time, part time or casual employees. For reporting purposes this figure includes all staff, including staff on leave without pay for any length of time.

Senator Colbeck asked:

Senator COLBECK—How many FOI requests does the government have in front of it at the moment?

Ms Hazell—There are 12 freedom of information requests currently being processed within the department.

Senator COLBECK—What is the ageing on each of those?

Ms Hazell—I am not sure I have the ageing with me. I would need to take that on notice.

Answer:

The Department of Agriculture, Fisheries and Forestry does not have access to information regarding the number of Freedom of Information (FOI) requests currently before the Government. For FOI requests handled by the department, as at 23 February 2009, there were 12 current FOI requests.

Of the 12 requests, one had been with the department for five days; one for 27 days one for 31 days; one for 32 days; one for 35 days; one for 46 days; one for 62 days, two for 95 days; one for 188 days; one for 300 days and one for 375 days.

In five cases, the department was required to consult with third parties. In three cases, the matters were subject to third party consultation and multiple internal reviews, initiated by the applicant and/or one or more affected third parties. One request is now awaiting a determination by the Administrative Appeals Tribunal. All requests were being processed within statutory time limits or within a revised timeframe agreed with the applicants.

An agency has 30 calendar days to process a request and notify the applicant of its access decision, and 60 days in most cases where third parties need to be consulted. The clock starts from when the request is received, but may stop intermittently where clarification is sought on the scope of the request, pending payment of associated charges, or to allow for review/appeal processes, if instituted, to be concluded.

While all of the above requests have included time periods where the clock stopped, the request with the department for 300 days was subject to time extensions sought by both the applicant and an affected third party.

The request for 375 days was subject to four separate requests for internal review by third parties, each objecting to a different part of the original access decision. As this request also involved an unusually large number of documents, the department sought a time extension from the internal review applicants to enable it to fully consider the material evidence to support their contention that the documents should not be released.

Electricity costs

The department's electricity costs for 2007-2008 were \$1,706,724, the year to date (to 23 February 2009) electricity costs for 2008-2009 are \$616,874 and the estimated electricity costs for 2009-2010 are \$1,665,225.

Fuel costs

The department's fuel costs for 2007-2008 were \$1,456,783, the year to date (to 31 January 2009) fuel costs for 2008-2009 are \$840,047 and the estimated fuel costs for 2009-2010 are \$1,448,500.

An update on major reviews, committees, taskforces and inquiries underway by the department as at 23 February 2009 has been provided in response to a question asked by Senator Colbeck (Corporate Policy Division 02 refers).

The department has entered into 139 consultancies for the period 1 July 2008 to 16 February 2009 at a total cost of \$12,254,561. A complete list of consultancies for the 2008-09 year to date is at **Attachment A**. This list does not provide the date that the contract was awarded as it would be an unreasonable diversion of departmental resources to ascertain the information. It does include the contract start and end dates.

The department entered into 239 consultancies for the period from 1 July 2007 to 30 June 2008 at a total cost of \$19,699,870. A complete list of consultancies for the
