**Part B** is a copy of your most recent audited financial statements that will enable the Visual Arts Board to understand the financial status of your operations.

#### SELECTION CRITERIA

Your application will be considered against the following selection criteria used for Key Organisations funding. Your application should provide evidence of:

- A vital contribution to the development of high quality contemporary art practice as shown by activity relevant to context. For example: service, touring, regional etc.
- the organisation's artistic and professional skills appropriate to the activity
- the ways in which your organisation engages with the public or membership as shown by audience development strategies and outcomes
- quality and Innovation in the organisation's ongoing program of local and national and/or international activities; and
- Sustainable planning, governance and management as shown by effective use of resources, including appropriate budgeting and remuneration of artists and staff

b) The Australia Council's Fair Notice provisions are followed in all cases. These provisions state that the Australia Council will give all multi-year funded organisations 12 months notice before a Board effects any material reduction in funding for an organisation.

All Visual Arts Key Organisations, including Craft Australia, were notified in November 2010 that multi-year funded organisations were under review and that their funding beyond December 2011 was not guaranteed. This was over 12 months before Craft Australia were notified of their unsuccessful application for Key Organisation funding for 2012-14.

The Dance Board placed Leigh Warren and Dancers (LWD) on Fair Notice in 2008 regarding concerns about levels of activity, associated audiences, lack of a strong touring rationale and strategy, and a poor business plan. LWD remained on notice until 2011, when the company was notified they were unsuccessful in receiving Key Organisation funding. This notice period was considerably longer than the 12 months required under the Australia Council's Fair Notice Protocol.
