Since responding to Senate Ryan's question on notice 154 from October 2011 Supplementary Budget Estimates hearing, the Department has entered into eleven consultancy arrangements up to 31 January 2012, listed at Attachment A, with a total dollar value of \$1,019,032 (GST inclusive).

The following variations and amendments have also been made during the period:

- A contract for research services for Local Government Water Management let to the University of Technology Sydney was increased from \$150,000 to \$208,604 reflecting an increase in the scope of works and an extension from 30 August 2011 to 30 March 2012.
- The regional broadband study let to Dandolo Partners was increased from \$70,000 to \$79,227 to reflect the time taken for stakeholder engagement.
- The review of Illawarra Regional Development Australia Committee's Regional Plan let to Marcoplan Australia was increased from \$29,500 to \$39,500 following an increase in scope to include an implementation plan and an extension from 21 October 2011 to 31 December 2011.
- A consultancy for the performance of a review of disaster reconstruction projects
 was previously reported as having been let to the Australian Government
 Solicitor instead of Oakton Services Pty Ltd. There was also a minor amendment
 to the previously reported amount, from \$26,752 to \$30,252.
