As at 31 January 2012:

- 1. The Department provides electronic equipment to Minister Crean and his office. The Department provides full range of ICT equipment including, network, servers, remote access services, telephony, desktop computers, printers, and portable devices, to the Minister and his advisors. The cost to set up the equipment in the Minister's Office was \$96,821.66. Year to date additional equipment expenses (1 July 2011 to 31 January 2012) are: \$2,118.00
- The Department provides departmental staff with a workstation, including desk, chair, personal computer, mobile devices (where appropriate), telephone and access to a printer.
 - Typical cost for this equipment for a staff member is between: \$3,871 and \$5,521.
 - The average cost per staff member for standard equipment is \$3,871. This cost includes leasing costs for a printer.
 - Based on operational requirements, some officers within the Department require to be provisioned with mobile devices to access phone and desktop services (laptop and mobile telephony; or desktop and blackberry). Depending on the configuration of the mobile solution package, the base cost per staff member can rise from \$3,871 to a maximum cost of \$5,520
