With regard to the \$16.5 million (GST inclusive) in grants provided to FFA to support football in the lead-up to the Asian Cup:

- 1. Exactly how has the grant money been used by FFA? (i.e. player payments, administrative costs, equipment, etc)
- 2. What accountability processes are in place to ensure the grants are used for the purpose for which they are intended?
- 3. Was payment of the second grant of \$8.25 million contingent on FFA attaining particular benchmarks in relation to the first \$8.25 million grant?
- 4. Will FFA receive further grants of this nature in the lead-up to the Asian Cup?
- 5. Does the Government intend to provide similar levels of financial support for other professional sporting bodies in the lead-up to other major international tournaments, e.g. the cricket World Cup, etc?

Answer:

1. The \$16.5 million (GST inclusive) of grant funding is being provided to the FFA as sustainability funding, it is not allocated to a specific program or purpose. The first \$8.25 million was provided contingent on the FFA agreeing to a review of their operations. This review was undertaken in 2011, led by the Hon Warwick Smith AM. Mr Smith's report, titled *Building Australia's Football Community*, was publicly released on 1 December 2011 and is available on the Internet. The second \$8.25 million is linked to milestones demonstrating implementation of the Smith Review's recommendations.
