#### **Senator RHIANNON asked:**

- 1. In its CTM "free range" application to the ACCC last year, the AECL proposed that a stocking density of 20,000 birds per hectare of outdoor area constitutes "free range" production.
  - a. What government funding was spent on the any activities that informed or supported this failed CTM application, including research and development?
- 2. The AECL's website states it represents approximately 400 commercial egg producers. How many of those producers run free-range production systems that would meet consumer expectations of 1,500 birds per hectare of outdoor area along with other accepted free-range conditions such as no beak mutilation?
  - a. What level of support does AECL provide for such producers? Please give details.
  - b. What processes and procedures does the AECL have to ensure smaller free-range producers' concerns and input is represented in the AECL?
  - c. Do such producers have any say in the research and development carried out by the RIRDC for example, or the AECL, in regards to free-range egg production systems? What sort of such input has been given and incorporated into any R&D that has received any public funding?
- 3. Have there been any concerns expressed to the AECL about its lack of support for smaller "true" free-range egg producers? What are the details please?
- 4. The ACCC is currently investigating a complaint about Coles and Woolworth's labelling of intensively stocked eggs as 'free range':
  - a. Please provide any details the AECL knows about this complaint?
  - b. How many of AECL member/producers provide Coles and Woolworths home brand free range eggs?
- 5. At what hen densities are those egg production systems run?

#### **Answer:**

- a) \$529 976.37 (comprising laying chicken levy (\$264 988.19) and Commonwealth matching Research and Development (R&D) funds (\$264 988.18).
- 2. Australian Egg Corporation Limited (AECL) is not aware of the total number of egg producers who run free-range production systems that would meet 1500 birds per hectare of outdoor area along with other specific free-range conditions.

- a) AECL does not classify its investments according to the type of production system used. All known egg producers, whether AECL members or not, have access to and benefit from AECL research and development (R&D) and promotional activities. All known egg producers also have the opportunity to provide input to AECL investments. Free-range egg producers with a stocking density of 1500 per hectare or less would benefit from a range of AECL investments to a greater or lesser degree depending on their particular circumstances.
- b) All egg producer concerns that AECL is made aware of are considered during the strategic planning process. AECL also receives and considers correspondence received from all manner of egg producers. AECL regularly convenes industry forums, ad-hoc workshops or meetings, board forums, and general meetings where all egg producers, small or large, have the opportunity to raise issues with AECL. One-on-one visits are also made to small and large egg producers by AECL management to discuss R&D or promotional investment issues.
- c) All egg producers known to AECL, small and large, are invited to take part in the strategic planning process to assist in determining the R&D objectives and priorities for AECL across all egg production systems. AECL regularly consults and seeks input from the On-Farm Innovation & Efficiency Industry Consultative Committee (ICC) and other forums such as the Hen Welfare Forum which includes egg producers from all different types of farming systems. Participation in the ICC is reviewed every two years and is open to all known egg producers who express an interest to participate. The ICC ranks all R&D projects submitted to AECL for funding, including preliminary research proposals and then full research proposals for subsequent investment. AECL understands that RIRDC does not undertake research regarding egg production.
- 3. Yes, mainly through telephone and e-mail correspondence. These concerns are associated with the highly competitive nature of the egg market, proposed maximum stocking densities and representation by AECL Board. AECL is implementing the recommendation in its May 2011 performance review, undertaken by AgEconPlus Consulting, that 'given changes to the Constitution, and some concern that AECL may favour the 'big end of town', an independent review of the AECL Board, consistent with the regular independent reviews undertaken by other similar-sized research and development corporations and the Australian Securities Exchange best practice...' be considered.

- a) AECL understands that the Australian Competition and Consumer Commission (ACCC) has requested Coles Supermarket to provide the following information:
  - all farms used for Coles brand eggs
  - a copy of the Coles standard
  - a copy of the RSPCA standard
  - a copy of the AECL standard.

AECL has no information on ACCC investigations into Woolworth's labelling of intensively stocked eggs except through general media.
