The Australian Government Cost Recovery Guidelines, administered by the Department of Finance and Deregulation, provide the policy for publication of cost recovery impact statements. These guidelines require all agencies to publish cost recovery impact statements online, as per Finance Circular 2008/08, but do not specify a timeframe for when a cost recovery impact statement should or should not be released.

The Department of Agriculture, Fisheries and Forestry publishes cost recovery impact statements as soon as practicable.

Provide evidence of industry being aware of the erosion of the IER, particularly the fact that the IER will drop below the agreed 10% level;

Provide evidence of industry being made aware of the consequences the IER falling below the 10% level and of the potential need for as increase in fees to bring the IER back up to the agreed 10%.

#### Answer:

The month by month balance of the Industry Equalisation Reserve (IER) for the Import Clearance Program from 1 July 2011 to date is shown at Attachment A.

Import Clearance program revenues and expenses for 2011–12 and forecast for 2012–13 are shown at Attachment B.

The Department of Agriculture, Fisheries and Forestry (DAFF) charges industry on a full cost recovery basis. The operating budget is set and monitored by the DAFF. Industry is advised of DAFFs financial performance against the budget throughout the year.

The agreed level of reserves held by DAFF is between 2 per cent and 10 per cent of annual expenditure, as outlined in the Cost Recovery Impact Statement (CRIS) at Attachment C. This equates to a range between approximately \$4 million and \$19 million. Since July 2011, the reserve has not fallen below the agreed minimum threshold of 2 per cent.

Consultation with industry is ongoing through the former AQIS Industry Cargo Consultative Committee (AICCC, meetings were held on 16 November 2011 and the 7 May 2012), and more recently the DAFF Cargo Consultative Committee (DCCC, the last meeting was held on 4 October 2012) and the Import Industry Finance Working Group. Financial performance of the arrangement and the impact on the Industry Reserve is discussed at each meeting.

The establishment of the reserve is based on agreement with industry outlined in the CRIS. The level of reserves is agreed to be managed between 2 per cent and 10 per cent. The reserve has not fallen below the lower limit. The CRIS discusses actions for remediating under-recovery of revenue and the erosion of the industry reserve below the agreed 2 per cent.

Credit card use is monitored through online processing by the cardholder, reviewed by an authorising officer and the credit card team. Periodic reviews are undertaken to ensure ceased officers have had their credit card cancelled. Reviews are also carried out on the number of cards with the Department of Agriculture, Fisheries and Forestry (DAFF) and associated limits of each card.

In the event of suspected credit card misuse, the item is reported to DAFF's Fraud and Security Team for appropriate action.

For the current financial year (to 31 January 2013) there have been eight instances recorded of use outside of the department's credit card policy. The range of staff classifications are APS5 to SES2. Six instances of misuse were due to accidental personal use, with the amounts being repaid in full to the department. Two instances of misuse were due to card holders splitting the full value of purchase over multiple transactions. These officers and their authorising officers were reminded of DAFF's policy on credit card use. This misuse represents less than 1 per cent of cardholders and credit card expenditure.

There are a number of actions aimed at the prevention of credit card misuse. These include the issuing of instructional information on using corporate credit cards, training, limiting access to credit cards on a needs basis and by setting transaction and monthly limits on cards.
