1. The ASC Security Steering Committee is assessing its compliance with the 33 'mandatory' requirements of the PSPF adopting aspects of the new policy as 'best practice'. As a CAC Agency, the ASC is not required to comply with the PSPF unless directed to do so by its portfolio Minister. No such direction has been given as at 5 March 2013.

As of 28 February 2013, the ASC compliance with the PSPF requirements is as follows: 11 compliant, 19 partially comply, one non compliant (No. 22: policies and procedures for protective control of information assets) and two that are still to be fully assessed (No. 10: International Agreements and No. 12: Contractor compliance). The ASC Security Steering Committee's mandate includes monitoring and delivering 'whole of government' changes to security and their potential impact on the way the ASC conducts its business.

The ASC's Protective Security Framework is built around five key policies of protective security. These policies are: Personnel Security Policy, Physical Security Policy, Information Security Policy, Security Investigations Policy and Risk Management Policy.
