Ms Fleming: There are a number of issues related to the constitutional recognition of local government. One is the timing of a referendum, and the IDC is looking at the timing and the risk issues. The other is the success factors or preconditions of success set out by the Australian Local Government Association and other experts, building on parliamentary reports in previous periods. Technically, there is still time to have a referendum and the JSC's final report will advise a joint parliamentary view as to whether the success factors, in their opinion, are likely to be met.

Senator JOYCE: Obviously states have every right to raise their concerns. There are states with serious concerns, one of them being, obviously, Western Australia; another one, to a lesser degree, being Victoria. Has the minister basically entered into closer negotiations with the Western Australians as to how we can deal with the issues of difference?

Ms Fleming: The minister has indicated that he is waiting for the final report. The JSC will have another hearing on 20 February and there will be a number of parties called to that, including me, and we will hear again what the states' positions are. Western Australia certainly raised its position in its submission to the JSC, and other states are still to confirm their position.

Senator JOYCE:When was the last time Minister Crean and the Western Australian minister sat in a room together?

Ms Fleming: I would have to take that on notice.

Answer:

There is ongoing discussion with the WA Government on a range of issues affecting local government.

Senator JOYCE: Can you provide an update of the Australian Local Government Workforce and Employment Census? I think it is being coordinated by the Australian Centre of Excellence for Local Government.

CHAIR: Can you make that your last question, Senator Joyce? Senator Fawcett is patiently waiting.

Ms Beauchamp: We will take that on notice.

Senator JOYCE: You will have to take this on notice, then. I also want to know how much funding has been provided for it.

Ms Fleming: For the centre, or for that project?

Senator JOYCE: I am interested in the census.

Answer:

The Australian Local Government Workforce and Employment Census (the census) is part of a suite of initiatives funded under the Local Government Reform Fund.

The census is designed to collect standardised workforce data from all 565 councils across Australia, to allow workforce analysis by region, state and council classification.

The census will enable councils to benchmark themselves against aggregated groupings of councils (national, state, and regional). The information will be used to improve workforce planning capacity within individual councils and to support sector-wide and jurisdictional efforts to address skill shortages, enhance the professionalism of local government and facilitate greater workforce diversity.

The census will also develop and maintain a nationally consistent dataset on women's participation in the local government sector, including both elected representatives and senior management positions.

The census deadline was extended from December 2012 to 21 January 2013 to provide councils affected by adverse weather events more time to respond. More than 160 councils across the country participated in the census, and a wide variety of council types and sizes is represented.

Data collation and verification has been done and analysis is under way. Initial results will be available to the Department in March 2013.

\$300,000 (GST exclusive) was allocated for the census.
