Mr Wilson—I will take it on notice, Senator, to give you a precise answer. Do you mean departmentally-employed staff? There is a difference between staff that we employ departmentally and employ through the Program to deliver services on the Islands. The Minister employs staff under the Act on the Island to deliver services under the Program. The Department employs staff on Christmas Island and in Perth to administer the Program.

Senator O'BRIEN—can we have those figures as two separate sets?

Answer:

Including the Indian Ocean Territories Health Service the Minister for Local Government, Territories and Roads directly employs by Ordinance 99 people to deliver services on Christmas and the Cocos (Keeling) Islands. These people are principally employed in -

- (a) the health services such as doctors, nurses, and health professionals;
- (b) the school in positions such as assistant registrar, secretary, teacher's aide (otherwise known as educational assistants), library officer, cleaners, gardeners and laboratory worker;
- (c) the Christmas Island Power Authority which manages the generation and distribution of power on the Island;

- (d) positions with property management functions in respect of buildings owned by the Commonwealth (public and employee housing) for example, property manager, housing officer, maintenance officer, cleaners and gardeners; and
- (e) corporate administrative positions including finance and accounts.

These include on Christmas Island 60 ongoing staff, 19 fixed-term or temporary staff, and 13 intermittent or casual staff. On the Cocos (Keeling) Islands, there are three ongoing and four fixed-term staff.

The employees are employed pursuant to the Administration Ordinance 1968 of the Territory of Christmas Island or the Administration Ordinance 1975 of the Territory of Cocos (Keeling) Islands and not the *Public Service Act 1999*.

In addition to these staff, there are two Departmental staff on Christmas Island.

In the Perth Regional Office, there are nine ongoing full-time and one ongoing part-time Departmental staff.

Is it the case that that Director of Nursing is employed on a fly-in, fly-out basis?

I am told that she works extended hours and receives overtime payments for hours she assigns to herself when she is on-island.

Answer:

It is standard practice in the WA Country Health Service for small rural hospitals (of fewer than 20 beds) which have a Director of Nursing (DON) for that role to have both a clinical and management role. Any robust clinical management system requires clinical management staff to interact with staff over the 24/7 period, and to ensure clinical standards are being maintained. This oversight can only be achieved by management being physically present on those shifts. The issue also arises when a permanent DON is in place.

There are, however, management systems in place to address any potential conflict of interest. The Manager of the Indian Ocean Territories Health Service (IOTHS) must give prior approval for any additional shifts to the DON's standard work hours and has a process in place for checking with the DON regarding rostering for clinical shifts. In addition, all DON hours and subsequent time sheets are signed by the Manager. The *IOTHS Code of Conduct* also requires all employees to avoid conflicts of interests and provides a process for addressing any perceived or real conflicts. The DON is not employed on a fly-in fly-out basis.

In relation to the use of a nursing agency, the Western Australian Nurses Agency (WANA) has been continually used by the IOTHS since 1999. WANA has provided two locum DONs in the past, for the periods May to June 2003, and July to

December 2003. This arrangement has not changed following the appointment of the current occupant.

The local representative is currently away from Christmas Island and negotiations will continue upon his return.

Is it possible for the Committee to receive a copy of a description of the Western Stevedores proposal for freight handling facilities on West Island? With a diagrammatic explanation of the facility?

Answer:

Western Stevedores' September 2003 Strategic Report on the Future Management of the Cocos (Keeling) Island Port proposed the construction of a low profile, piled jetty with crane and adjacent hardstand at the current container-transfer location on West Island, and that the location be protected by a breakwater constructed of tetrapod modules. New shallow draft barges would also need to be purchased to enable transfer of freight directly between the new jetty and the ship.

A preliminary design for the jetty is included at **Attachment A**.

In subsequent discussions with the Department of Transport and Regional Services, Western Stevedores have modified the preliminary concept, extending the deck at the end of the jetty with a view to increasing the facility's wave-dampening capability, and removing the necessity for a tetrapod breakwater.


Senator O'Brien asked:

On the 27 May 2005, the Department advised the Senate Rural and Regional Affairs and Transport Legislation Committee that it was working with the Shire of Cocos (Keeling) Islands to establish burial arrangements on West Island of the Cocos (Keeling) Islands. In particular, the Department indicated that is was in discussion with the Shire regarding the transfer of Crown land for the purpose of a cemetery.

The Shire has since advised that it no longer requires Crown land for this purpose as it had previously identified a portion of land (controlled by the Shire) on West Island in their Town Planning Scheme. The **attached** map shows the proposed location.

The Commonwealth funded Indian Ocean Group Training Association (IOGTA) is a registered training organisation with scope to provide accredited training in the following programmes:

- Certificates I, II, III and IV in Business;
- Certificates III and IV in Business Administration
- Certificate IV in Business (Small Business Management);
- Certificate III and IV in Business (Frontline Management);
- Certificates II and III in Conservation and Land Management;
- Certificate I and II in Information Technology;
- Certificate II in Information Technology (Applications);
- Certificate III in Information Technology (General);
- Certificate I and II in Hospitality (Operations);
- Certificate II in Tourism (Operations);
- Certificate IV in Assessment and Workplace Training; and
- Diploma of Training and Assessment Systems.

IOGTA is able to deliver these courses on both Christmas and the Cocos (Keeling) Islands.

In addition, where there is sufficient community interest in a particular course, IOGTA has, with Commonwealth support, arranged for mainland trainers to visit the Territories to deliver training.

It should be noted that Years 11 and 12 students from the Cocos (Keeling) Islands normally study in Perth and only a very small minority remain on-Island to continue their studies via distance education.

Students from both Christmas and the Cocos (Keeling) Islands who elect to study on the mainland are provided with 4 return trips to the Territories per year, similar to that available in WA for students living in remote communities. In addition, they are normally eligible for Assistance for Isolated Children (via Centrelink) and may be eligible for Youth Allowance Payment (via Centrelink) which is means tested.

Students who elect to remain on-Island (principally Christmas Island) receive no special allowances, but are provided with an annual return airfare to the mainland to attend distance education camps.

Should a subsidy be triggered, it would be based on the tendered budget submitted by National Jet. The budget cost does not include a profit margin. In effect, the Government would make up the difference between revenue obtained over the subsidy period and an adjusted budget cost of providing the services. Budgeted fuel and exchange rate costs are adjusted to reflect cost differences between the actual costs during the subsidy period and the costs assumed in the budget. Other budget costs are adjusted for CPI.
