In September 1999 the Wheat Export Authority, established in July 1999 under the Wheat Marketing Act 1989, sought applications from suitably qualified individuals for the position of Chief Executive Officer who would report to Members of the Board through a non-executive Chairman.

Recruitment for this position was managed by 'Agricultural Appointments'.

The role was advertised as a new role within the Authority with a pivotal role to play in the export of Australian wheat, and requiring a senior executive who could manage wide ranging relationships with dedication and poise operating within and across both the public and private sectors.

The skills set sought was based on the standard Australian Public Service Senior Executive Service criteria, and included the following:

- Strong leadership qualities, strategic awareness and vision coupled with judgement and initiative;
- A first class track record in policy development;
- Sound administrative skills;
- Excellent written and oral communication skills;
- Highly developed analytical and conceptual skills;
- Familiarity with the operations and working relationships of the public sector and Government accountability processes;
- Experience in or knowledge of the grains industry and grain trading; and
- Demonstrable ability to develop and direct research and policy analysis.
