Senator Stephens asked:

And it is a question for the Minister. It is about output 2; it is about the Country Women's Association Emergency Drought Aid Fund. I wonder if anyone can tell us where that is up to. There is \$3 million in that fund for this year. It is used as part of emergency assistance to distressed families in drought and other extenuation circumstances, but there is nothing there for next year

Answer:

The \$3 million Country Women's Association (CWA) Emergency Drought Aid Fund was part of the Prime Minister's Drought Assistance Package announced in May 2005. This funding has been fully allocated across the CWAs in each State and the Northern Territory from the 2005-2006 budget.

Based on monthly reports received from the CWAs, funds distributed by CWAs up to 31 May 2006 is some \$2.5 million. It is estimated that \$2.7 million of the funds will have been distributed by the CWAs by 30 June 2006.

The CWAs have agreed to continue distributing these funds to eligible individuals and communities until the remaining funds are fully distributed. It is anticipated that the \$3m funding package will be fully distributed by the end of the first quarter in 2007.
