Answer

The ACT Water Skiing Association has undertaken a trial of water skiing training in East Basin of Lake Burley Griffin from November 2005 – February 2006.

The trial has been assessed by external environmental experts against a range of environmental parameters including noise, silt disturbance, turbidity, bank erosion and the impact on wild life.

The NCA has consulted on the trial with lake users through the Lake Users Group and other stakeholders including the ACT Hospice and the Boathouse Restaurant which are located nearest the training course.

An announcement on the outcome of the trial was made by the Minister on 22 June 2006 when a report on the impact of the trial on the lake environment was also available on the NCA website.
