Dr O'Connell—The overall idea is that payments to the states are consolidated in what are called national partnership programs and they become single payments to the state each month, which are across the board, across whole of government, if you like. Other departments have the same thing. They retain the policy responsibility for the programs; it is simply that the money that goes out is appropriated to the Treasury and is then fed to the states on a consolidated monthly basis. It is a more efficient way of making payments.

Senator COLBECK—So you can come back to us and give us any detail of any potential employment impacts of moving that.

Senator Sherry—We will take that on notice. If we can provide an answer by tomorrow, we will do so. In saying that, my expectation is that we should be able to provide you with an answer on that.

Senator Sherry – We will have to take that on notice, Senator.

Answer:

There have been no redundancies for staff aged between 54 years 11 months and 55 years in the Department of Agriculture, Fisheries and Forestry (the department) in the last three years.

The number of staff who have resigned between the age of 54 years 11 months and 55 years for the last three years is as follows:

2006-07: 11 2007-08: 25 2008-09 (as at 25 May 2009): 8

The department does not have the information available to answer on a whole of government basis how many staff resigning from the department between the age of 54 years 11 months and 55 years have come back as contractors anywhere in government.

Within the department, information on contractors is not held centrally and it would be an unreasonable diversion of resources at this time to collect the data for the 2006-07 and 2007-08. During 2008-09, four staff who resigned between the age of 54 years 11 months and 55 years have returned as labour hire contractors.

The Department of Agriculture, Fisheries and Forestry's Graduate Development Program is run over a calendar year from January to December and graduates complete three rotations during the graduate year.

In 2007-08, (January 2007 – December 2007), Australian Quarantine and Inspection Service (AQIS) placed between four and five graduates per rotation (numbers vary from rotation to rotation). Biosecurity Australia placed four graduates.

In 2008-09 (January 2008 – December 2008) AQIS placed between four and five graduates per rotation and Biosecurity Australia placed three graduates.

At the completion of the 2007 Graduate Program in December 2007, three graduates were placed in permanent positions in AQIS and four in Biosecurity Australia.

At the completion of the 2008 Graduate Program in December 2008, four graduates were placed in permanent positions in AQIS and one in Biosecurity Australia.
