Answer:

The government has accepted all Beale recommendations in principle. Implementing these reforms will take some time and will be subject to normal budget processes.

A number of activities are currently underway. New legislation to replace the *Quarantine Act 1908* is being developed. The Commonwealth, states and territories are developing a national agreement on biosecurity, which will help shape an improved national system.

As noted in the government's preliminary response, a number of interim administrative arrangements have been implemented. From 1 July 2009 an interim Inspector General of Biosecurity has been appointed to audit and verify Australia's biosecurity systems; interim arrangements to enhance the Eminent Scientists Group to include economic expertise have been put in place; and the current pre-border, border and post-border biosecurity functions of the Department of Agriculture, Fisheries and Forestry have been consolidated into a new business unit—the Biosecurity Services Group. The Biosecurity Advisory Council, replacing the Quarantine and Export Advisory Council, will be appointed in 2009 to provide advice to the Minister for Agriculture, Fisheries and Forestry on biosecurity matters across the biosecurity continuum

The Beale Review supported the former government's decision to allow the 40 per cent discount of AQIS export certification functions to lapse at the end of June 2009. New fee schedules have been negotiated with all industry sectors to begin on 1 July 2009. The return to 100 per cent cost recovery on 1 July 2009 for AQIS export certification functions has been completed in close cooperation with industry.
