The National Indigenous Languages Policy (NILP) was put in place in 2009 to

provide a national approach to supporting the revival and maintenance of Australia's

Indigenous languages and guide all the bodies involved in this work.

Since 2005-06 the Indigenous Languages Support program has invested around

\$72 million into language activities and in 2012-13 it is providing \$9.9 million.

The House of Representatives Standing Committee on Aboriginal and Torres Strait

Islander Affairs is currently undertaking an inquiry into language learning in

Indigenous communities and we look forward to seeing the findings and

recommendations later in the year.
