Senator BERNARDI: I would be interested in ongoing feedback in respect to this, because clearly we do not want to see fewer people doing it and we do not want to see the supervision diminished either, which I think is very important when kids are getting involved in sport. In the portfolio budget statement there is no key performance indicator for this program that sets a goal to get at least 60 per cent of the active after-school participants expressing interest in joining a sporting club or team, which was the case in the previous PBS. Why was this key performance indicator removed from this program?

Answer:

The key performance indicator related to Active After–school Communities program participants expressing interest in joining a sporting club or team was not included in the Australian Sports Commission 2012-13 PBS as an independent evaluation of the program to gather this data will not be conducted in this reporting cycle. It is anticipated this will occur in 2013. The transition of children from the Active After-school Communities program to sporting clubs and programs will continue to be a focus of the program in 2012-13.

Senator BERNARDI: Yes. You can take it on notice. I am interested in what areas of research you intend to undertake over the next 12 months. I understand there may be some sensitivity to that, given the competitive situation internationally and things of that nature, but I would broadly like to receive any information you can give.

Mr Hollingsworth: Yes, I would be happy to provide that on notice.

Answer:

AIS research projects are geared towards five broad themes.

- 1. Athlete Preparation acquiring new knowledge to better prepare athletes for international competition.
- 2. Athlete Resilience researching the wellbeing of athletes through injury and illness prevention, recovery and psychology.
- 3. Skill, technique and tactics providing athletes and coaches with feedback and equipment to enhance performance and maximise skill acquisition.
- 4. Pathways for athletes and coaches acquiring new knowledge about development pathways for high performance coaches and athletes.
- 5. Podium Preparedness providing athletes and coaches with cutting-edge knowledge to enhance competition performance on the day.

AIS research projects involve a number of sport science and sport medicine disciplines including psychology, recovery, physiology, physical therapies, nutrition, biomechanics, skill acquisition and performance analysis. Some research projects are specific to science or clinical areas, whilst others can be multi-disciplinary.

A list of 49 applied research projects has been confirmed for the next 12 months. The AIS anticipates that at least 25 of these will be completed by 30 June 2013.

Examples of some research projects include:

- Recovery and performance: developing guidelines for hydrotherapy during intensive training preparing for London 2012
- Impacts of concurrent heat acclimation vs. heat acclimation

Senator FAWCETT: I am quite concerned about the level of support not being provided in some cases to wounded soldiers, and this is a fantastic initiative, so I am keen to flesh out what degree of funding is there, who it is coming from and how we can make sure that continues. Could I also put on notice, because I am assuming you may not know off the top of your head, how many ADF people are likely through their involvement to also be on the actual Olympic team that ends up going?

Mr Eccles: Yes. We will speak with the Department of Defence, who I think is involved in that earlier issue that you just raised; but we will look into that as well.

Answer:

On 12 May 2010, the Australian Paralympic Committee in partnership with the Australian Defence Force (ADF) launched the ADF Paralympic Sports Program and Association. The aim of the program is to direct ADF members, who acquire a disability during their employment, into Paralympic sport. It is anticipated that no ADF member from this program will make the 2012 Australian Paralympic Team. However there are currently former members of the ADF who will be on the Team, however their involvement has been prior to the establishment of the relationship.

The funding also supports Paralympic sport programs and initiatives such as the Paralympic Education Program, classification, broadcasting for the 2012 London Paralympic Games, talent search and mainstreaming.
- The Australian Government did not provide any grant funding to the Australian Olympic Committee for the 2012 London Olympic Games.
- 3. Government funding provided to the Australian Paralympic Committee is for high performance outcomes, as per the Australian Paralympic Committee's high performance plan endorsed by the Australian Sports Commission (ASC).

The Authorised Ticket Reseller, Paralympics Australian Travel Office (part of the General Travel Group), has approximately 220 tickets remaining for sale. Approximately 95 per cent of tickets allocated to Australians have been sold.
- The Australian Paralympic Committee appoints a ticket reseller, who has an agreement to be the authorised ticket reseller in Australia. For the 2012 Paralympic Games, the ticket reseller is the Paralympics Australian Travel Office, part of General Travel Australia.
