- b. Did DRALGAS provide electronic equipment to the Minister and Parliamentary Secretary and their offices, what are the ongoing costs for this financial year to date? What were the running costs for 2009-10 and 2010-11?
- c. Is electronic equipment (such as ipad, laptop, wireless card, vasco token, blackberry, mobile phone (list type if relevant), thumb drive (not an inclusive list)) provided to DRALGAS staff? If yes provide details of what is provided, the purchase cost, the ongoing cost and a breakdown of what staff and staff classification receives it.
- d. Please update if there have been any changes since Additional Estimates 2011-12 (February 2012): Does DRALGAS provide the Minister and Parliamentary Secretary and their offices with any electronic equipment? If yes, provide details of what is provided, the cost and to who it is provided.

Answer:

- a. The Department provides mobile phones to Minister Crean and his office. Phones provided are Blackberry or standard mobile phones. The Minister has also been provided with an iPad. The initial establishment cost for these devices can vary, but typically falls in the range between \$595.00 and \$1,500.00.
- b. Yes, the Department provides electronic equipment to Minister Crean and his office.

The ongoing cost associated with provisioning electronic equipment including user support service for the Minister and Parliamentary Secretary and their offices, are covered through the shared services arrangement with the Department of Infrastructure and Transport and are not separately identified.

- c. The Department provides departmental staff with a workstation, including desk, chair, personal computer, mobile devices (where appropriate), telephone and access to a printer.
 - The majority of staff are provided with standard equipment (i.e. \$3,871 per staff member). This cost includes leasing costs associated with multi-function devices and printers.
 - Based on operational requirements, some officers within the Department require mobile devices to access phone and desktop services (laptop and mobile telephony; or desktop and Blackberry). Depending on the configuration of the mobile solution package, the base cost per staff member ranges from \$3,871 to \$5,520.
 - Staff classifications range from APS1 through to the SES Band 3.
- d. Since Additional Estimates, the Minister's office has been provided with a polycom upgradable sound station (for teleconference calls) and a new printer tray. The costs incurred in this reporting period (1 February 2012 31 May 2012) are \$2,075.

- 1. The Department makes use of a Whole of Australian Government agreement in place with ERM Power Pty Ltd.
 - Details of this agreement can be located on <u>www.finance.gov.au</u>.
 - The Department entered into this electricity purchasing agreement on 20 May 2011.
 - The period of the agreement is 1 July 2011 to 30 June 2015.
- The Department was established on 14 September 2010 and as such there were no electricity costs associated with the Department for the 2009-10 financial year.
 Electricity costs for the Department for the period of the 2010-11 financial year

were approximately \$166,979.

 Electricity costs for the Department for the current financial year to 24 May 2012 have been approximately \$206,482. This amount includes electricity costs for additional functions added to the portfolio at the end of 2011, including the Office for the Arts and Office for Sport.
