to questions on notice will probably come far too late in terms of election periods and things.

The financial year 2013/14 capital program contains one new ILS proposed for Gold Coast Airport. Airservices is also installing an ILS at Gladstone Airport, funded by the airport.

Senator Smith asked:

Senator SMITH: So, specifically around initiative No. 2 of the Airport Capacity Enhancement program, if I am correct, it has five particular activities and when this was signed there were three of them planned and two of them completed. What is the progress report against those three planned activities?

Mr Harfield: Can I take that on notice just so that I can give you the accurate information?

Senator SMITH: Yes.

Answer:

Activity 3: Include the High Intensity Runway Operations (HIRO) information in Aeronautical Information Package (AIP) Departure and Approach Procedures (DAP) and En Route Supplement Australia (ERSA).

Identification and implementation of the appropriate High Intensity Runway Operations (HIRO) procedures and techniques for Perth Airport have been developed and are scheduled for promulgation to industry in October 2013.

Activity 4: Conduct controller/pilot forums

Fifteen meetings of the Perth ACE Management Team have been held to coincide with the timing of pilot/controller forums. In addition, dedicated sessions with higher levels of representation from these groups are being periodically convened by Airservices to address specific air traffic service topics.

Activity 5: Establish performance measurement and reporting regime

Progress against this activity includes:

- development of the Operational Runway Analysis (OpeRA) software tool to streamline the process of recording manual observations;
- subsequent collection of operational data using this tool in both February and April 2013; and
- establishment of a Data Integrity Reporting Team to provide reporting capability associated with airport performance and operational efficiency. The availability of a routine Perth Airport Daily Performance Report is a priority activity.

In addition, the runway performance measurements have been statistically analysed and have already been shared and discussed with industry.

With the planned introduction of the Advanced Surface Movement Guidance & Control System (ASMGCS) at Perth Airport in 2014 it will be possible to automate the collection of a broad range of runway performance metrics at which stage the ACE program will generate monthly Runway Occupancy Time reports as is the current practice at Melbourne and Brisbane Airports.

Senator Smith asked:

Senator SMITH: So, at the last estimates you talked about having limited success in terms of the airport capacity issue. You talked about an aspirational goal—they are my words—of looking for 10 to 20 movements an hour. How far progressed are we in terms of reaching that aspirational goal?

Mr Harfield: We have made some improvement. To give the quantum I will take that on notice and we will provide that.

Senator SMITH: While we are talking about taking things on notice, the strategic plan and roadmap contains 103 initiatives to improve airport capacity and in March this year 10 were described as completed, three were described as active and 89 were described as planned. What I would like to know, as of May, what is the number of completed, number of active and number of planned? In addition to that, I am just keen to understand too that we are talking the same language, so when we say 'planned', they have been identified and planned or identified, planned and activated. So, are they underway?

Mr Harfield: We will give you the proper definition so we will be talking of the same thing. Senator SMITH: I would be keen to know what the definition is around 'completed' as well.

Answer:

The first review of arrival rates at Perth Airport since the commencement of this program in October last year was held at the Perth ACE meeting in August 2013. The review identified opportunities to increase rates during peak arrival periods and operating procedures are being developed to safely deliver improved efficiencies.

In relation to the strategic plan and roadmap a number of terms are used to assist in the tracking and planning of the associated activities:

- Planned This is a scheduled activity within the Strategic Plan that has not commenced;
- Active This activity is in progress; and
- Completed This activity has been completed or is finished.

The status of the 103 activities that were identified in the Strategic Plan as at the end of August 2013 is 27 completed, 39 active and 37 planned.

Senator Rhiannon asked:

Senator RHIANNON: On this issue of flight paths I am getting complaints from people around East Melbourne near the MCG. They are reporting that in their area aircraft noise was previously less intrusive because the aircraft were flying over waterways and highways. I am told that many of them feel that this is no longer the case, with the aircraft flying over residential areas. Has there been a change in the regulatory regime, or however you manage this, which has permitted a change in the flying patterns and is resulting in the complaints that I am now receiving?

Ms Staib: I am aware of the issues around East Melbourne and specifically regarding the helicopter noise around the MCG. We have been in communication with Adam Bandt to understand exactly because he has represented to us some complaints. This week we received details of what his concerns are—that is, what days and so on—and we are investigating that now. I cannot tell you now whether it has been a change in the regulations but I will take that on notice.

Senator RHIANNON: When will you be able to get back to us, because for many people it is a weekly or a daily problem? When would you be able to follow up on that?

Ms Staib: Would within a fortnight meet your requirements?

Senator RHIANNON: Thank you.

Answer:

There has been no change to regulations or the manner in which traffic is managed.

Senator Rhiannon asked:

Senator RHIANNON: I would be interested in any specific response about April with regard to a lot of flights in Melbourne, but also more generally can you take on notice if there are many flights above whatever the limit is, because they do not have to register or whatever it is when you are below that height. Are you judging that this could become dangerous at some point because of the number of aircraft in the air?

Mr Mrdak: I think it is important to be clear that aircraft that are operating over residential areas do not operate without air controls. Mr Harfield is setting it out for you and it would probably be beneficial to give you some information about the nature of aircraft operations over urban areas. There are no aircraft that operate in a manner which is unsafe or uncontrolled.

Senator RHIANNON: I will ask that in a different way, as I may have misunderstood the response. I thought that the response was that above a certain height you do not have to put in flight plans?

Mr Mrdak: No.

Ms Staib: It is below a certain height.

Mr Mrdak: It is in certain airspace areas. I think it is probably best to get you some information on notice to explain that, because I do not want to leave any impression that there are aircraft operating without any controls or regulatory requirements. That is far from the case.
