'Since 2001, the government has spent \$1.2 billion in assisting 53,000 families through the drought'.

The agriculture minister used the same figures in answer to a question on 12 October. Is that actual expenditure or funds committed?

Mr Koval—The \$1.2 billion is actual expenditure.

Senator O'Brien—How does that break down by year and by program?

Mr Koval—Would you like me to read them out or provide a table on notice at a later date?

Senator O'Brien—I would be interested to hear them. If we can have the table, that would make it easier.

The following table shows a breakdown of Australian Government expenditure, through the Department's portfolio, on drought assistance by year and programme. The table also shows non-portfolio budgeted costs for drought assistance through Health Care Cards, Youth Allowance and Centrelink delivery costs.

Senator O'Brien asked:

You can give us those figures with the assumptions for the breakdown of expected take-up, can you?

Mr Koval – We can certainly do that. On an area-by-area basis or just the total?

Senator O'Brien – Area by area.

Answer:

The projected take-up rate for Exceptional Circumstances Relief Payment in each Exceptional Circumstances declared area was determined by using the maximum number of farms to have received income support since the area was declared. The projected take-up rate for Exceptional Circumstances Interest Rate Subsidies was estimated by using the number of Interest Rate Subsidy applications received over the previous 12 month period for each Exceptional Circumstances area. For areas that were opened to all producers, Exceptional Circumstances Relief Payments and Exceptional Circumstances Interest Rate Subsidy take-up rates were estimated at ten percent of additional producers covered by the declaration.

The \$350m and \$560m announcements were preliminary estimates for support.

The table below shows the breakdown of costs for Exceptional Circumstances areas included in the October 2006 announcements.

Senator Ferris asked:

Acting Chair—Do you have any figures that would indicate the number of people who could be affected by that? Does your department keep figures on rural apprentices?

Mr Thompson—No, our department does not keep those figures.

Acting Chair—Would it be possible for you to have a look and see whether they could be supplied to us so that we can see the breadth of the numbers of people who are at risk? Clearly when the drought ends a number of these young people may no longer be in these places. One of the difficulties is that when you lose that infrastructure it is often difficult to get it back.

Mr Thompson—I appreciate that. We would have to approach other government departments to obtain that information, but some information would no doubt be available about the number of apprentices in rural areas, perhaps by sector or something like that.

Answer:

The National Centre for Vocational Education Research estimates that there were 157,300 apprentices in training across all industries in rural and regional areas at 31 March 2006. This represents 39 per cent of the total number of apprentices in training across Australia.

Senator Ferris asked:

Could you give me any indication of the number of appeals that might be lodged and the rate of success of those appeals?

Mr Koval—I do not have the number of appeals.

Acting Chair—You might need to take that on notice.

Acting Chair—I would appreciate it if you were able to tell me what rate of appeal there is and what percentage of those appeals are successful. I realise that you may need to take it on notice.

Mr Koval—I will also need to contact the states to get the latest information.

Acting Chair—That would be useful.

Answer:

The number of applications for Exceptional Circumstances Interest Rate Subsidies that were declined and the number of those producers who appealed that decision can be found in the table below. The figures were sourced from the state government Rural Assistance Authorities who administer the Exceptional Circumstances Interest Rate Subsidies.

Two States, New South Wales and Victoria, initially only recorded the number of applications they declined. They commenced recording the number of declined applications that were appealed at a later date.

For example, the New South Wales Rural Assistance Authority recorded the number of declined applications from November 2002, where as, the number of appeals were recorded from July 2003. The Rural Finance Corporation of Victoria recorded the number of declined applications from February 2003, where as, the number of appeals were only recorded from January 2004 onwards.

The States are unable to provide the data on an area by area or timeframe basis and can only provide it as aggregate data. It should be noted that the information provided may under-report the number of appeals due the time gap in recording this information.
