## **Senator Macdonald asked:**

Senator IAN MACDONALD—But just to follow on with Senator Siewert: it will be a matter for the committee, but I would be recommending that we get the department and the environment department back to go through these in some more issue. I see in the answer you gave me to questions at last estimates about the number of jobs lost. The thing that sticks out is you say you are not a job employment counter so you did not know. But, Mr Thompson, you would have heard or been made aware of the last person who gave evidence the other day who, of her knowledge down in the Gippsland, could name ten people who had lost their jobs in the NRM area in the last few months because of uncertainty of funding. I really ask, and put on notice because I do not think I asked this in the other one, if you can give us an indication of how many people you are aware of who have lost their jobs since 1 July 2008. I see you gave me some figures in answers previously which said there were more people employed on 7 May 2008 than there were on 20 November 2007. That just cannot be right. It just cannot be right.

**Mr Thompson**—Senator, those numbers that we provided you earlier this year were numbers provided to us by the regional bodies themselves or the state governments on behalf of the regional bodies. We do not employ these people, so we have to rely on the advice we receive from the bodies that employ them, and they were the numbers that they provided to us. We do not regularly update it, but if you want us to update those numbers we can.

**Senator IAN MACDONALD**—I would. But could you please try to get a little more—and I am not suggesting you are being dishonest; I appreciate you are just repeating—but could you get from the people that are giving them to you some honesty in the figures? All of the anecdotal evidence shows that every NRM body, with the exception of those along the Barrier Reef, have been losing staff because of lack of guaranteed funding.

#### **Answer:**

In September a response was provided to this question.

20 Nov 2007 a total of 1891.32 full time equivalent positions were employed; and 7 May 2008 a total of 1882.58 full time equivalent positions were employed.

The question was asked again in October, not all regional bodies were able to supply the employment figures within our timeframe. Therefore the interim figures are:

1 July 2008 a total of 2130.7 full time equivalent positions were employed; and 20 October 2008 a total of 2055.1 full time equivalent positions were employed.

Both permanent employees and non-ongoing contractors are included in these totals. We will supply you with a final total when all the regional bodies figures have been made available.

The Australian Government is not responsible for monitoring employment data for regional bodies as many are state statutory bodies and others are independent incorporated bodies. This information has been provided to us by state and regional organisations and cannot be verified.

The Australian Government is not the only source of funds used to employ regional staff. Regional NRM bodies also receive significant resources from state and territory governments as well as from private corporations and philanthropic bodies. Variations in the size of contributions from these other sources will vary over time and will also impact on regional staffing levels. It is not possible for the Australian Government to accurately project future employment by regional bodies.

## **Senator Macdonald asked:**

**Senator IAN MACDONALD** - What I just want to ask this department is, what work are you doing as part of the Reef Rescue package, a Labor Party pre-election policy which they are implementing with \$200 million? A lot of that will involve interaction with the sugar industry, the banana industry, the cattle industry, grazing industry up along the Barrier Reef. Have you as a department done work on that? Having asked the question, I do not think I can allow the time for the answer, so perhaps you will just have to take that on notice and give it to me in writing.

**Mr Thompson**—We can take it on notice.

#### Answer:

The \$200 million Australian Government Reef Rescue initiative will provide funding for water quality grants to build partnerships between key stakeholders, including between traditional owners and reef managers, develop Traditional Use of Marine Resource Agreements, monitor the reef lagoon and its catchment and fund priority research projects required to support and enhance Reef Rescue outcomes.

On 23 October 2008, following negotiations with regional bodies, the Regional Groups Collective, CaneGrowers, AgForce, Growcom, Queensland Dairy Organisation, Cotton Australia, Queensland Farmers Federation and the Queensland Government, the Australian Government announced a package of proposals for 2008-09 totalling \$23 million.

Delivery of Reef Rescue in the region will capitalise on the strong partnerships forged between regions and industry to engage regional farmers in a number of projects to improve water quality. These projects include:

- Providing incentives to farmers to adopt improved technologies such as GPS guided controlled-traffic farming, a soil conservation farming method that reduces compaction and erosion;
- Managing and re-vegetating cane drains to slow the movement of water to allow for the removal of excess nutrients and sediments;
- machinery conversions that provide precision spraying capabilities resulting in the more efficient use of fertilisers and herbicides in the paddock; and
- repairing chronic low ground cover in grazed areas to reduce erosion.

**Senator COLBECK**—So that \$7.5 million is expended, effectively?

**Mr Hurry**—That is my understanding unless the department has any difference. I do not know whether it took the full \$7.5 million for the purchase or not.

**Mr Thompson**—I do not have details of the funding but that is my understanding that—

**Dr O'Connell**—We will take that on notice.

**Mr Thompson**—the buybacks on the Torres Strait were completed before the end of the financial year.

**Senator COLBECK**—Could you take on notice the final costs of that work? **Dr O'Connell**—We will.

Representatives from the Game Fishing Association of Australia (GFAA) and the South Australian Recreational Fishing Advisory Council Inc (SARFAC) were also invited to the forum. GFAA declined the invitation for involvement and SARFAC did not respond.

What are the names of the individual programmes [under Caring for our Country] in place and how much funding has been allocated to each programme to achieve each of the six national priority areas under the Caring for our Country programme?

#### **Answer:**

In March this year the Government announced that \$2.25 billion would be available to support the new Caring for our Country initiative over the next five years. This includes a guaranteed base-level allocation to the 56 regional NRM bodies of \$159 million in 2008-2009 and \$138 million annually in the next four years, \$189.2 million from 2008-09 to 2012-13 for landcare, and a number of 2007 election commitments such as the \$200 million Reef Rescue and \$100 million Community Coastcare. Since Caring for our Country commenced on July 1, the Government has announced a number of additional programs under the Caring for our Country initiative to achieve outcomes under the six national priority areas. Table 1 provides details on those programs and sub-elements that have been announced in 2008-09 under Caring for our Country

#### **Landcare Sustainable Practices Grants**

The degree to which project proposals were likely to achieve National Landcare Program outcomes was assessed against the following criteria:

- Encourages the uptake of sustainable production practices within the NRM region or across regions.
- Practical and technical competency
- Demonstration of good value for investment and a clear public benefit
- Outcomes are clearly defined and can be delivered within the specified timeframe
- Consistency with priorities in regional NRM plans (applicants should consult with your regional NRM organisation)
- Compliance with any relevant legislation and other relevant intergovernmental arrangements, and
- Identification of key risks and proposed risk management strategy.

## **Community Coastcare**

All Community Coastcare applications are assessed against the following criteria:

- Anticipated environmental and sustainable land management outcomes in line with caring for our Country national priorities
- Knowledge sharing and potential to raise community awareness and enhance skills
- Value for money of the proposed activities
- Demonstrated high public benefit, and
- Level of partnership with other organisations (e.g. community, regional natural resource management organisations, non-government, industry).

#### **Open Grants**

Open Grants proposals were assessed against the extent to which they:

- deliver outcomes that are likely to significantly advance outcomes in the Caring for our Country national priority areas targeted for 2008-09
- demonstrate a strategic and integrated delivery approach
- demonstrate a high level of partnership and/or engagement with other organisations, and

## **Environmental Stewardship**

Environmental Stewardship takes a market-based approach to investment which is targeted at improving the quality and extent of targeted high public value environmental assets. These assets are chosen from matters of National Environmental Significance under the *Environment Protection and Biodiversity Conservation Act* 1999. Individual land managers opt to participate through an expression of interest process run within target areas by a Delivery Agent appointed through a tender process.

Individual land managers' sites are assessed and scored for their environmental significance and the management actions that are agreed to be undertaken. Individual land managers submit a price for which they would be prepared to undertake the agreed management actions on the site. The site score is divided by the price for each bid received, and these indices are then used to rank the individual bids in a value-formoney continuum.

An independent evaluation committee considers the ranking using a marginal cost curve, and other relevant information such as the unimproved capital value of the land and the available budget, in determining a list of successful bids which are then recommended to Ministers for approval.

## **The National Reserve System**

The national reserve system element of Caring for our Country is the responsibility of the Minister for the Environment, Heritage and the Arts.

The government is also establishing a Recreational Fishing Advisory Committee to provide advice to the Minister for Agriculture, Fisheries and Forestry on strategic recreational fisheries issues and initiatives to help the industry's development. The recreational fishing sector will be invited to provide input through the committee advising the Minister.

The Government has not made any ongoing commitment to provide core funding to these organisations. The Government has invested \$198,680 in a \$314,730 Recfish Australia consultancy aimed at securing a reliable and independent-from-government revenue stream for Recfish Australia. A report by the consultancy on strategic revenue options for the sector is due in January 2009.
- 3. The Australian Government recognises recreational fishing as an important tourism and cultural activity in all Australian states and territories and has committed \$2 million over three-years to develop and implement a Recreational Fishing Industry Development Strategy.
