Senator COLBECK asked:

- 1. Since January 2012 \$23,111 has been spent, in two parts, on DAFF carbon farming handbook. Why was this handbook only delivered to "Canberra"? Has it been distributed to DAFF regional offices?
- 2. What was the final spend on publications for the 2011-12 financial year?
- 3. Which DAFF publications have been printed in hardcopy, the cost and where were they delivered to since 1 July 2012?

Answer:

- 1. The Carbon Farming Initiative (CFI) Handbook was produced by the Department of Climate Change and Energy Efficiency. All copies of the carbon farming handbook were delivered to the Department of Agriculture, Fisheries and Forestry (DAFF) Canberra office for storage and distribution to appropriate channels. The handbook was provided to any persons or organisation upon request. Copies were not sent to DAFF regional offices as they mainly serve a biosecurity function. However, approximately 6720 handbooks have been distributed to Regional Landcare Facilitators, Rural Financial Counselling Service Program service providers, agricultural advisors, industry bodies, Landcare Groups and individual farmers and land managers.
- 2. The final spend on publications for the 2011–12 financial year was \$215 064.30.

- The *ABARES Agricultural Commodity Report* is posted to over 170 subscribers across Australia and internationally, as well as over 20 Australian federal politicians.

Senator COLBECK asked:

21 clients represented by Minter Ellison have been reported in the budget papers as having a class action against the government for live exports. When was the department first aware of this class action?

Is the claim being managed through this department and what types of information if any has the department provided on this issue?

The budget papers indicate there is potential for an "unquantifiable" lawsuit connected to the ban on live exports last year, and the media are reporting the value to be in the hundreds of millions of dollars.

What are the potential implications to the \$1.5bn surplus promised by Minister Swan, or has some contingency already been made in the budget?

Answer:

Minter Ellison first advised the Commonwealth that they act for a number of clients who allegedly suffered losses as a result of the temporary suspension of live-stock exports to Indonesia on 8 December 2011. However, to date no class action has been filed in any court.

It is standard practice that when an agency receives notice of a potential claim of litigation, the agency notifies Comcover, the Commonwealth's insurer, who therefore controls the defence. Under the *Legal Services Directions 2005*, agencies must also report all significant issues that arise in the provision of legal services to the Office of Legal Services Coordination (OLSC) within the Attorney General's Department. The Department of Agriculture, Fisheries and Forestry has complied with these obligations.

As this is a matter which may potentially come before the courts, it is a long standing government practice not to comment further until the matter is resolved.
