The Lombok Treaty

Submission 56 TT 6 December 2006

We see that the Agreement between Australia and the Republic of Indonesia on the Framework for Security Cooperation now requires ratification.

Article 2.3 of that Agreement states that the Parties are to refrain from anything which constitutes "a threat to the stability, sovereignty or territorial integrity of the other Party, including by those who seek to use its territory for encouraging or committing such activities, including separatism, in the territory of the other Party."

This article is obviously referring to West Papua and is an effort to curtail the right of the West Papuan people to gain freedom from oppression, as well as to deny the freedom of dissent to those who recognise that right. If there is a separatist movement in West Papua we must ask "Why?" The answer is that the West Papuan people have been oppressed by the Indonesian military, their resources have been taken and many people have been killed.

The military's operations in West Papua resemble those it conducted in East Timor up to 1999. We are dismayed that over 300 Indonesian military persons responsible for abuses in Timor have not been brought to account. <u>www.cavr-timorleste.org/</u> Some have been promoted in military or civil administration in Indonesia (see "Careers of Selected Officers" attached). In too many cases individuals responsible for mayhem in East Timor were promoted to positions of power in West Papua, e.g. Police Chief Timbul Silaen and Brigadier General Mahidin Simbolon. Once bitten, twice shy.

It is not in Australia's interest to support the repression which the Indonesian military has carried out in West Papua. The ratification of this Agreement would do just that and would pave the way for the continuation of such behaviour. Ratification of this Agreement would make Australia party to the Indonesian military's operations in West Papua.

It is not in Australia's interest to try to silence its own citizens. This Treaty challenges the right to support our near neighbours under the guise of protecting stability and territorial integrity. We believe that regional stability can only be built on the protection of human rights.

Unless its wording is changed, this Treaty is set to introduce yet another human rights abuse into both nations, that of trying to silence conscientious dissent.

We ask the Committee to consider carefully the future effect on Australia and on Indonesia of ratifying an Agreement which ignores, and therefore condones, institutional attacks on the life, limb, property and culture of the indigenous people of West Papua. Strong international relations are not served by ignoring any people's rights to live in safety and to withstand oppression. We call on the Committee to exercise your power by re-writing the Agreement, introducing into it a clear provision for the protection of human rights.
