2. Should Australia become a party to this Code:

It would place all Australians under the control of a foreign alien power without their individual knowledge or authority, and

It would place all Australians under an authority that will be concerned more about the interests of more powerful nations and assets than it would be about Australians, and

Australians would have no reasonable or democratic control over future developments of the Code.

3. Australia must not become a party to this Code:

All persons involved in the support of such involvement will have committed an act of treachery against the Australian people for which they will be held fully accountable.
