Thank you for your request for comment on the new policy direction of Government announced on April 7, 2009 in relation to the National Broadband Network.

| g. | Extent of demand andfactors influencing consumer choice for broadband products | With the switchover to Digital television by 2013 and lack of availability of spectrum, the future of the rich offerings and valued role of Indigenous Community Television and Indigenous Remote Media Associations themselves are at risk, their survival hinging on their capacity to use broadband to 'go digital' and embrace web-based platforms and products, explore converging media opportunities across digital television, mobile phones, computers via operating community telecentres (where remote people can access training and support, and develop their ability become 'content producers') is contingent upon a well serviced broadband environment! |
| h. | any technical, economic commercial, regulatory, social or other barriers that may impede attaining the Government's stated goal for broadband availability | There is concern that what with significant language and cultural barriers; along with the geographical isolation of our stakeholders, once again an appropriate consultation process will be omitted in relation to the rollout of the NBN - leading to inappropriate and undesirable outcomes for remote communities. |
| | | To avoid this occurrence IRCA would strongly recommend the allocation of one of the 12 Rural NBN Coordinator's being proposed, be based at and work with IRCA as the peak body. This would enable the NBN Company to engage with the 8 Remote Media Organizations (with whom IRCA teleconference on a monthly basis). This would facilitate close consultation with RIMOS, their technicians and importantly their Indigenous Board Members, who have intimate knowledge of their egions needs and practices and could assist the Government identify and provide the best options. |

IRCA also wishes to advise the Committee that it is awaiting confirmation of funding to conduct a Digital Futures Forum in Alice Springs in early September to bring policy makers, practitioners and stakeholders from the Sector together to discuss the technologies, changes and opportunities afforded by the coming rollout of the national Broadband network and the Switchover to Digital Television by 2013.

Thank you for this opportunity to comment. We are greatly encouraged by the policy and look forward to working with Government to ensure best results for remote Indigenous Australians.
